

B. Request a Wakka Wakka Perpetual Crown Lease to replace Land Title

- 1. Complete the form for a Perpetual Crown Lease to replace existing 'land title'.
- 2. Supply a map of your property from council showing Lot # and Subdivision #
- 3. Receive a Perpetual Crown Lease signed and sealed by the Chief Elder
- 4. A copy will be sent with a Notice of Jurisdiction to the relevant Australian Govt offices
- 5. A notice of Private property (no trespass) is also sent
- 6. Recommend 3 X Private Property Notices erected from the front fence to the front door
- 7. Recommend becoming a member of Royalregistrydejure.com.au to protect your property

C. Record motor vehicles with Wakka Wakka Nation

- 1. Complete form for each vehicle
- 2. Receive Travel documents including
 - Licence to travel freely on all Roads within Australia
 - Notice to any person acting as an officer or agent of the Aust Govt
 - Copy of each vehicle recorded with the Wakka Wakka Nation
- 3. Recommend getting CTP Insurance from one of the 4 suppliers
- 4. Recommend recording all vehicles with the RRDJ same as for property

D. Educate yourself and practice daily until proficient in understanding the following

- 1. Living in the Private. Ask questions. Do not answer any questions.
- 2. The Constitution of the Wakka Wakka Nation

Take notice that this interaction may be recorded. I am Iirragala Radjah Radjah and I am of sound mind. What is your name and number and in what capacity do you act?

I am a Tribal Member of the Wakka Wakka Nation, the traditional custodians of this land and together with all the tribes in Australia, we are the true custodians of the land. This pre-dates occupation by the British Admiralty.

The Native Title of the Original people is recognised by the Mabo case: Mabo vs Queensland (No 2); decided June 3 1992 by the High Court of Australia.

The Wakka Wakka Nation was re-established in October 2023 with the notification to all corporations acting as the Federal, State and Local levels of the Australian Government as well as the Queensland Police Service.

International Law recognises the inalienable right to self determination. The Law of Nations (Vattel, 1758) states that one can leave a nation, one can start a new nation and an emerging nation can expect the continued support of the incumbent nation.

A Declaration of Peace and Cessation of War was issued on the 16/10/2023. I am here and unarmed and come in peace. The people and property here are private and your trespass is infringing international humanitarian law.

Take notice that you are creating an international incident, breaching the UN Declaration of Rights of Indigenous Peoples and the International Protocol of Political & Civil Rights should you continue with your curent action.

You are required to stand down and stop infringing on me.

Take Notice that these penalties apply to you personally for the following actions:

- 1. Denial of travel of any man or woman = AUD \$1,000,000 per day or part thereof.
- 2. Arrest or detain any man or woman = AUD \$1,000,000 per day or part thereof.
- 3. Take possession or interfer with private rights or property = AUD \$1,000,000 per day or part thereof.

These penalties apply to each man/woman and for each infringement, cumulatively.

I am now continuing on my way, thank you. Peace to you and have a great day.



being of adult age of 21 years or more, has the right to free and unrestricted travel in whatever private property or mode of travel he/she chooses to travel in, on the Tribal lands of the Sovereign Nations, on any surface, road, airway, waterway, train and the like, provided that at all times she:

- 1. Respects, maintains and protects the land the aire and the water, and
- 2. Respects, maintains and protects all living things, flora and fauna, and
- 3. Travels safely and considers the safety of one's self and all others above all else,
- 4. and Respects tribal custodians' traditions and requirements during travel.

This contract is valid, holding superior jurisdiction, above all and any other claim.

This contract may only be forfeited if any of the above terms are proven under Wakka Wakka Law/Lore to be breached before a Jury of peers.

Royal Registry de Jure (RRDJ)



Set up by Victorian lawyer Spiros Kalotihos, RRDJ is a System of Registration which is in the Private, outside Govco jurisdiction.

(Spiros held the Vic Minister for Health to account in court in the early days of lockdowns.)

There are two levels of membership:

1. Full registered membership. Cost \$999 to register property, vehicles, and stock, and a Gold Investment Account or Interest account. This is not a bank account.

Private from Govco - means no taxes rates fines etc.

Safe from big banks - no freeze accounts or bail in etc

Your wealth is invested 100% in Gold and Silver and not held in AUD\$.

It is kept in the vault of the bullion company.

2. Public membership. Cost \$200 for a Gold Investment Account only.

The \$200 will be credited if you become a full registered member.

To Apply for funds - it is a lifetime loan which can be recalled - all anonymous and cannot be traced or tracked to you.

- transfer to any RRDJ account
- a promissary note to another RRDJ member
- Pay to any BSB and account#
- Mastercard (like a gift card) loaded with your funds in \$1000 increments and it is anonymous
- Withdraw in gold/silver
- Any currency or denomination

If you want cash, you request an amount paid into a BSB and account number which you can withdraw cash from. You have to manage your own cash. Cannot draw cash on the the mastercard or use online to make payments.

Three of our ministers are now members and Wakka Wakka Nation has a Gold Investment account thanks to a \$200 donation.

3. Getting started

Go to www.royalregistrydejure.com and read every page

For a full membership, download the form

For a public membership, pay \$200 fee and complete the online form for a Gold Investment Account (or interest account)

You will get a reply with your membership number and a different account to deposit you funds

Both these accounts are in Spiros name – remember this system is in the private, so personal names and relationships matter – no corporations.

You can immediately request funds as listed above.

It took about two weeks to receive a Mastercard, then email for the PIN number

You can request a balance of your card or your account or any query at any time by email to steward@royalregistrydejure.com

4. Benefits

You are investing in Gold/silver without having to store it personally

You take more responsibility for your investment and your cash

Your wealth is directly governed by the change in gold/silver prices

And not pinned to the AUD\$ which has devalued about 7% pa for the last 70 years

- that has halved in value each decade

All your payments and purchases are annonymous

The Banks cannot bail you in; The Govt cannot freeze your funds
